After learning about this incident, the top management of the company attached great

importance to it and assigned Alice Cui to be responsible for contacting the Global Compact organization and striving to reapply for the restoration of the company's membership. They also designated another colleague. At the same time, it is required that the company's management actively implement the ten principles of the Global Compact within the company, ensuring that the ten principles of the Global Compact are fully implemented in their work. It is decided to summarize and review the achievement of the goals of the ten principles of the Global Compact implemented in the company at the year-end summary meeting, and form a COP report to report the achievement of the goals to the Global Compact organization. We are reapplying for the restoration of our membership in the United Nations Global Compact organization. We promise to actively implement the ten principles of the Global Compact within our company, incorporating environmental protection, respect for human rights, employee health and safety, and anticorruption into daily management, and continuously improving management performance.
