We also pledge to participate in and engage with the UN Global Compact in the following way(s):

Its main activities are: 1-To monitor the usage of its members' works. To this end, SGAE collaborates with technology companies to implement tools for identifying and tracking these works. 2-To negotiate tariffs and to licence companies (TV and radio broadcasters, digital platforms, recording companies, concert organizers, theatre companies, and other businesses) for the commercial use of these works, promoting respect for intellectual property. 3-To collect and distribute fees to its members, ensuring that they are fairly compensated in commercial contexts. SGAE is actively advocating for an ethical AI that balances innovation with fair regulations on how tech companies should use and remunerate copyrighted works. Furthermore, SGAE has recently established a Sustainability Directorate to develop and implement strategies aligned with the UN SDGs, which will drive responsible collaboration with the private sector, and promote sustainable business practices.
